Refugee and Immigration Legal Service

Day Volunteers

Day volunteers help us from RAILS' office in South Brisbane during RAILS' operating hours, 9am to 5pm from Monday to Friday. We ask for a commitment of one day per week for a minimum of six months.

Intake Volunteers

Intake volunteers support our busy and fast-paced intake team. They are often the first person our clients talk to when they come to RAILS or call our office. Intake volunteers assist with admin and data entry tasks.

Evening Volunteers

Evening Advice Sessions Volunteers

Through Evening Advice Sessions (EAS), RAILS provides general legal advice for disadvantaged people living in Queensland.

EAS takes place on Wednesday evenings, from 6pm to 8pm and clients are advised by telephone.

EAS volunteer advisors are supported and supervised by a RAILS lawyer during the session.

Volunteer Advisors

We are seeking volunteers who:

- Are aligned with the organisation values and commitment to social justice.
- Are registered migration agents or immigration lawyers who can provide clients with general immigration advice about their matter.
- Are based in Queensland.
- Have experience completing records of their advice.

We normally ask for a commitment of one night per month for a minimum of 6 months.
